## **C2503-9 FOSSIL FUEL ADVERTISING AND SPONSORSHIPS POLICY**

### **Proposed Amendment by Cr Adin Lang**

Amend part 1.3 b of the draft policy to read as follows:

- b. the advertisement is of a temporary nature and not displayed more than ~~48~~ 12 hours prior to an event or ~~48~~ 12 hours after the events conclusion.**

#### **Reasons for amendment:**

To decrease the time the fossil fuel advertisement is displayed, where it meets the policy provisions.
